



**Charles Wolf, Jr.**

Senior Economic Adviser and Distinguished Corporate Chair in International Economics, RAND

Charles Wolf, Jr. is senior economic adviser and holds the distinguished corporate chair in international economics at RAND. He is a Professor of Policy Analysis in the Pardee RAND Graduate School, and received his B.S. and Ph.D. degrees in economics from Harvard. From 1967 until June 1981, he was head of RAND's Economics Department, and thereafter was director of RAND research in international economics. He was the founding dean of the RAND Graduate School, and served in that capacity from 1970 to 1997.

Dr. Wolf is a Senior Research Fellow at the Hoover Institution, and was a director of Capital Income Builder Fund, Inc. and Capital World Growth and Income Fund, Inc. from 1986 through 2010. Dr. Wolf has served with the Department of State, and has taught at Cornell, the University of California at Berkeley, UCLA, and Nuffield College, Oxford. He is the author of more than 250 journal articles and the author or coauthor of two-dozen books including *Foreign Aid: Theory and Practice in Southern Asia* (1960, Princeton Press), *Rebellion and Authority: An Analytic Essay on Insurgent Conflicts* (1970, Markham), *The Costs of the Soviet Empire* (RAND, 1986), *Markets or Governments: Choosing Between Imperfect Alternatives* (1993 MIT Press), *The Economic Pivot in a Political Context* (1997), *Asian Economic Trends and Their Security Implications* (2000), *Straddling Economics and Politics: Cross-Cutting Issues in Asia, the United States, and the Global Economy* (2002), *Fault Lines in China's Economic Terrain* (2003), and *Looking Backward and Forward: Policy Issues in the 21<sup>st</sup> Century* (2008), *Modernizing the North Korean System* (2008), *Enhancement by Enlargement: The Proliferation Security Initiative* (2008), and *U.S. Combat Commands' Participation in the Proliferation Security Initiative* (2009), *A Smarter Approach to China's Currency* (2011, Policy Review), *China and India, 2025: A Comparative Assessment* (2011), and *China's Expanding Role in Global Mergers and Acquisitions Markets* (2011) He is a frequent contributor to *The Wall Street Journal*, *The Asian Wall Street Journal*, *The Wall Street Journal Europe*, *The Weekly Standard*, *The New York Times*, *The International Herald Tribune*, *The Los Angeles Times*, and *The International Economy*.

Dr. Wolf's main research and policy interests are the international economy, international security, and the relations between them.
