What is a Charter School?

O Charter Schools are Independent Public Schools

- 0 Federal Reform movement ideally suited to Chinese Immersion and other critical languages
 - 0 Site-based management
 - 0 Parent-driven choice schools
 - 0 innovative educational models
 - 0 freedom in exchange for high accountability
 - 0 flexibility in hiring Highly Qualified Teachers
- 0 Fiscally independent, tuition free




GVA Immersion Model

Full to Partial Immersion, where 50% of the day is spent in the target language is the most effective instructional model, producing the highest proficiency levels.



Three Phases of Starting A Charter School



Phase One: Planning

- 0 Establish a Founding Board of Directors
 - Operate under Open Meeting Laws
- **0** Determine the Mission, Vision, Educational Model
- **0** Write Charter Application
- 0 Establish Legal Entity
 - 0 Articles of Incorporation
 - 0 By Laws
 - 0 Federal I.D. Number
 - 0 Bank Account: Charter School Planning Grants, Donations

Stakeholders

- Federal and state departments of education
- Authorizers: School districts and institutions of higher education
- Charter School Leagues and Associations
- Chinese organizations in your community. There are more than you think.
- Parents and families with K-12 students, who are interested in enriched educational experiences, immersion education, and/or foreign languages

O Academic and Operational Goals Sound Educational Program School Culture and Climate: A day in the life... Plan for At-Risk Students (RtI, ELL, SPED) **O** Accountability and Assessment Plan Organizational Leadership, Structure, Capacity Staff Qualifications, Recruitment Plan Financial Plan: 5-year Budget, Grants, Cash Flow Facilities Plan or Strategy



- Per-Pupil Operating Revenue (PPOR) and Capital Construction Funding: Charter schools are publically funded in the same way as traditional public elementary schools.
- Start-up Grants: Apply for start-up grant through your state.
- .gov grants: Chinese is deemed a critical language by the U.S.
 Department of Defense, leading to several federal grant programs.
 Consider the FLAP Program run by the NSEP and STARTALK programs.
- Han Ban in China: will send free text books in many cases, offer exchange teacher programs, and may fund some projects for K-12 education in Chinese language and culture. Contact the local Chinese consulate to start.
- Local University: Chinese language and education programs may be interested in curriculum development and research. Partner with Confucius Institutes.

Marketing

- **0** Send out press releases, contact TV and radio stations—Chinese Immersion is an interesting topic!
- O Talk to people as much as possible about your idea: send letters and emails to legislators, hold public meetings at libraries, send direct mail brochures
- **0** Participate in all events and fairs related to Chinese and education in your community
- 0 Launch a website that includes an online enrollment form for letters of intent. Create blogs, twitter and yahoo groups, and other online chat forums
 0 Develop a recognizable logo

Planning Phase I Milestones

0 Corporation established
0 Board is functioning
0 School is planned and designed
0 Charter application is approved
0 Community support is solicited
0 Have many *Letters of Intent* to enroll
0 Possible facilities are identified



Phase II: Start Up

- Adopt Governance Structure: Carver, Traditional Nonprofit, or Corporate Governance Structure
- Recruit and Hire Principal and Staff
 O Contracts, Benefits, Job Descriptions
- Systems Implementation
 Forms for everything!
 Funds Accounting System
 Student Information System
 Enrollment Systems
 Report Card Systems
 - O Communications Systems



Identifying Quality Staff

- **0** Teachers must meet federal NCLB "Highly Qualified" requirements but do not need to be state certified
- 0 Guest Teacher Program through College Board
- **0** Use Chinese educational websites in the U.S. such as CLTA, and state-wide websites such as MNK-12 Chinese listserve.
- **0** Advertise in local and national newspapers and job posting websites.

Milestones for Start Up Phase II

- **0** Occupy fully furnished building
- 0 Systems in Place: Student Information, Assessments0 Curriculum
- O Technology Plan Developed: Phones, Computers, Smart Boards, Security Systems
- **0** School is fully enrolled and staffed
- **0** Board is meeting once per month

Phase III: Operations

0 Training and Supporting Staff

- 0 Developing and Refining Curriculum, Instruction, and Assessment
- O Communicating with Parents, Community and Stakeholders
- 0 Network: ACTFL, Asia Society, CAL, CARLA

Design and Implement Curriculum

O Connect with other immersion programs nationwide. Invite teachers to your school to meet and train your teachers.

0 This is content-based: state standards and themebased teaching/hands-on teaching. The same strategies for ELL work in immersion.

0 Be intentional about literacy development

Data and Assessments

- 0 All public schools are accountable to standards for state testing in English.
- **0** Use the ELLOPA/SOPA at least one time, if not two times a year, to evaluate student oral language growth.
- O Develop grade-level standardized literacy tests, based on reading and writing curriculum outcomes. Use backwards design to develop these. Where do you expect children to score in character recognition, comprehension, and writing skills by the end of your program? (Stamp, HSK)

Milestones for Fully Operating School

- No less than 85% of students meet core subject and Chinese language proficiencies benchmarks
- High student retention. Wait list is long -- 300 plus students
- Positive fund balance and potential for facilities bond financing
- High parent satisfaction
- Low teacher, administrator, and Board of Director turn over
- Substantive community partnerships
